## HOUSE COMMITTEE MEETING MINUTES August 24, 2021

The meeting of the House Committee was called to order at 7:35 p.m. by Chairman Gene Gabel. Present in addition to Mr. Gabel was Committee member Keith Endy and ex-officio member Frank Deery. Committee member Barry Christman was absent.

Also in attendance were Council members Charles Heller and Lori Carnes; Marianne Deery, Mayor; Patricia Loder, Borough Manager; Nathan Laucks and Ralph Schoenly, Inframark, LLC; Tom Unger, SDE, Inc., and Jason Newhard, SSM, Inc.

A motion to approve the minutes of the July 20, 2021 meeting of the committee was made by Mr. Gabel, seconded by Mr. Endy, and approved.

Mr. Gabel called for public comment on the agenda; no comments were forthcoming.

## **Unfinished Business**

**25 South Reading Avenue** – Relocation of the driveway is complete and the contract has been paid in full.

Lighting and Parking Lot Layout Plan 25 SRA & 16 WPA – Mr. Unger reviewed with the Committee three options for the parking lot layout. Following discussion the Committee and Council members present agreed that Parking Option 2 is the best option; establishing thirty three parking spaces in the upper portion of the lot. Mr. Unger will obtain pricing for milling and macadaming an area between the lower and upper portion of the parking lot. Mr. Unger will also make the minor modifications required to the lighting plan.

## **New Business**

**Use and Occupancy Permit for Transfer of Ownership** – A lengthy discussion was held concerning requiring the issuance of a Use and Occupancy Permit upon the transfer of property ownership. Mr. Unger noted these inspections are typically looking for health and safety concerns, such as GFI outlets and smoke detectors. Mr. Newhard stated that Leesport Borough recently considered this issue; however, after receipt of significant negative responses from their residents and careful consideration of the pros and cons decided against enacting an ordinance to require a U & O upon transfer of ownership. Discussion was also held on a municipal trash collection program. Following all discussion, it was agreed that further discussion on requiring the issuance of a U & O upon transfer of property ownership, and a municipal trash collection program.
